

#### 1. INTRODUCTION

These guidelines were developed by QIMA IBD Certificações and establish the criteria that cosmetic products, raw materials for cosmetics, and food must meet to obtain IBD Vegan certification.

This 3<sup>rd</sup> edition was developed to update and balance concepts and criteria of the IBD Vegan certification seal with the products carrying this seal when marketed. The mission of QIMA IBD Certificações is to apply these guidelines to inspection and certification according to ISO 17065 requirements.

#### 2. JUSTIFICATIONS

The demand for guarantees of cosmetic products, sanitizing agents, and food free from animal-derived substances is consistently increasing.

Towards this fact, QIMA IBD created the seal that will ensure, not only through documentary verification but also through on-site audits, the optional exclusion of substances, raw materials of animal origin, or their derivatives.

#### 3. WHAT ARE VEGAN PRODUCTS?

- They are raw materials or final products manufactured without substances from vertebrate or invertebrate animals, including adjuvants, additives, catalysts, dyes, sweeteners, stabilizers, emulsifiers, and that these latter substances have also not been produced with animal products.
- 2) They are raw materials or final products that have been generated or manufactured without testing on animals of any species.
- 3) IBD Vegan certification does not exempt the company from complying with other relevant legislation, technical regulations, and standards, and making declarations regarding the allergenic nature of the products and the possible presence of allergenic substances.

#### 4. LIST OF PERMITTED AND PROHIBITED PRODUCTS

#### LIST OF PERMITTED PRODUCTS

It must be ensured that all raw materials used:

- i) do not contain any ingredient of animal origin, such as meat and substances derived from animal parts or their secretions;
- ii) do not contain any additives, supplements or enzymes derived from animal;



iii) has not been processed with technological adjuvants derived from animals; When necessary, provide a declaration in accordance with Annex I

#### **LIST OF PROHIBITED PRODUCTS**

## THAT BEING SAID, HERE ARE EXAMPLES OF SUBSTANCES AND DERIVATIVES NOT PERMITTED:

Milk derivatives:	lactic acid; casein; caseinates; cream; yogurt; milk powder; lactoalbumin; lactitol; lactoglobulin; lactose; whey; butter; cheese; whey protein.
Egg derivatives:	albumin; egg powder; globulin; lysozyme; ovalbumin; egg lecithin.
Honey derivatives:	Apitoxin; Wax; Royal jelly; Propolis; Polen.
Animal-derived ingredients: marine animals, bovine, insects, ovine, fish, swine, birds, or any animal species:	Silk aminoacid; Collagen and elastin, leather, gelatin, bones, cartilages; Carmine, Cochineal, Carminic Acid; Shellac; Fats; Guanine; Lanolin; Keratin (obtained from the protein extracted from the mane, feathers, and horns of some animals); Tallow or Animal Oils;
Hydrolyzed Proteins	(may be potentially derived from animals).

#### 5. LABELING

According to the National Health Surveillance Agency (ANVISA), the packaging label is defined as any inscription, legend, image, or any descriptive or graphic matter that is written, printed, stamped, engraved, or affixed to a product's packaging, and all elements must comply with current regulations.

Thus, all designs must follow the current regulations, and each regulation has specific requirements.

#### ANNEX 1. DECLARATION OF ANIMAL PRODUCT EXEMPTION

To ensure that the products to be certified have their raw materials verified, please send the following declaration of conformity - one for each raw material in the formulation:

#### **DECLARATION FOR VEGAN INGREDIENTS**

#### **IBD Criteria:**

The IBD criteria established for vegan cosmetics is that all raw materials and the manufacturing process must meet the conditions of not being tested on animals and not containing ingredients of animal origin.

#### **Declaration:**

The products listed below were obtained or manufactured without substances from vertebrate or invertebrate animals, including adjuvants, additives, catalysts, dyes, sweeteners, stabilizers, emulsifiers, and these latter substances have also not been produced with animal products.
